To the People of Oklahoma:

I am pleased to issue the December monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full disclosure of all activities within my office. As always, my staff is available to answer any questions you might have.

Market Conditions

At year-end U.S. Treasuries posted their best yearly returns since 2002. Losses tied to subprime mortgages drove demand to the safety of U.S. government debt. Two-year Treasury yields dropped 177 basis points in 2007 closing at 3.04% at month-end and the benchmark 10-year Treasury fell 68 basis points for the year to close at 4.02%. U.S. stocks managed to post gains in 2007 even though the fourth quarter was disappointing. The Dow Jones Industrial Average fell 101 points at month-end to 13,264, the S&P 500 dropped 10.13 points, and the Nasdaq Composite Index declined 22.18 points. For 2007 the Dow average rose 6.4%, the S&P 500 advanced 67% and the Nasdaq Composite climbed 9.8%, its biggest rally since 2003. The Federal Open Market Committee (FOMC) lowered its target for the federal funds rate by 25 basis points to 4.25% at the December 11th meeting. Investors were disappointed at the size of the cut, driving the Dow Jones Industrial Average down 294 points. In its statement the Fed said the quarter-point rate cut, which pushed the federal funds rate down a full percentage point below where it stood in early August, "should help promote moderate growth over time." The discount rate was lowered to 4.75%.

Economic Developments

The Institute for Supply Management reported that its index of manufacturing activity was 50.8 in November after posting 50.9 in October. Manufacturing continues to grow with continuing strength in new orders. The unemployment rate stayed at 4.7% for the third consecutive month. Average hourly earnings jumped 0.5%, to \$17.63 but earnings are up just 3.8% from a year ago. In November, the producer price index (PPI) rose at its fastest rate since 1972 jumping to a seasonally adjusted 3.2% as gasoline prices soared 35%. Over the past year the PPI has risen 7.2%. November retail sales rose a strong 1.2%. The consumer price index (CPI) rose by a seasonally adjusted 0.8% from October to November. This was the largest monthly gain in two years. Rising energy prices accounted for more than two-thirds of the gain. The Conference Board's consumer confidence index rebounded in December to 88.6 from a two-year low of 87.8 in November. Consumers' expectations about the future improved somewhat, but more said jobs are hard to get. Single-family housing starts have fallen 55% from their peak in January 2006. New home sales in November were down 34.4% from a year ago. Declines in home prices are affecting countries other than the U.S. In the United Kingdom home prices have fallen two months in a row. It appears that rising interest rates, tightened mortgage and credit conditions across the globe are hurting housing markets world-wide.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 4.78% in December and the weighted average maturity was 419 days. There were no significant changes in asset weightings. The year-to-date monthly average investable base was \$3.610 billion. Portfolio diversification continues to be sound. U.S. Treasuries represented 15% of holdings, and U.S. government sponsored enterprises accounted for approximately 45%. Mortgage-backed securities were 6% and Commercial Paper was 4% of the portfolio. Certificates of Deposit represented 9% of assets, money market mutual funds 7% and 9% was maintained in overnight repurchase agreements. Link deposits (at 1%), State Bond Issues (at 3%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on market conditions, portfolio strategy will consist of a combination of laddered maturities and market observation for investment opportunities.

Collateralization

All funds under the control of this office requiring collateralization were so secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees, mutual fund operating expenses and fees charged by JPMorgan Chase for the Tri-Party Repurchase Agreement Program are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.



In February 2007, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2008. The amount estimated was \$152,845,269. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison December 31, 2007

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at Northern Trust ("Northern").

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



The State Treasurer participates in a Securities Lending Program with The Northern Trust Company ("Northern") acting as lending agent. Northern retains 25% of the revenues generated as compensation for services. Its share for the month was \$128,486.03. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
